A Novel Strategy

Strategic Doing has been a mantra of mine for what is now well over a decade. Now I will try to apply the principles of Stregegic Doing to continuous and continuing progress toward completion of DISCOVERY, a novel.

This recognizes that progress has been made and will continue. Based on reading of David Baboulene and others I have been putting together a Step Outline for the book.

My vision is a book of around 120-150 pages revolving around the fictional characters Reg and Paula Huttering, two accomplished individuals who struggle with a relationship that is complicated by their respective professional obligations and aspirations as well as by middle age fantasies about their lives and the lives of others of their acquaintance.

The Step Outline will identify between 40 and 50 events in which characters energize a plot that has national and even international implications for higher education. These events will divide between three acts or parts for the novel. A general expectation is that around 7-8 events will form Act One and lead to an inciting incident, which will involve Reg leaving Paula abruptly afer they have made an attempt to get away and sort out what has been troubling their lives and relationship(s). Act Two will involve a series of 25-30 events with Reg and Paula alternating in protagonistic and antagonistic roles of various sorts leading to a turning point before resolution is possible. Act Three will unravel the tangle of events as needed to enable a resolution for Reg and Paula that enables them each and collectively to proceed with future positive direction.

The events of Act Two will involve university research, faculty relationships, ambitions and frustrations, an administrative quandary over survival of the university (or at least its identity) and outreach to a competitive-sister university in Michigan.

The Step Outline will provide sufficient event details and character relationships to assure that an emerging narrative will flow smoothly and logically, with character-driven action and dialogue that will tell the "goddamn" story. Following Baboulene, I intend to flesh out each event (scene, chapter) with knowledge gaps involving mystery, conflict and frustrations, dilemma after dilemma to sustain reader interest from first page until the last page.

The backstories for the two principle characters as well as several of the minor characters will be delivered through dialogue and character behaviors that will highlight or emphasize emotional considerations that are reflecting the history and values of each character. The Arc for the principal characters will emerge through the events of Act Two. This will intentionally position Reg and Paula to recognize change in their lives as enabling resolution and new directions that may not be perfectly satisfactory but will reflect the realities of their life situations.

The matter of university survival will remain obscure or mysterious but foreshadow a path toward growth in a new direction reflecting the dramatic changes that technologies such as genetics and bioengineering enable as well as societlal changes involving philosophy (existential) and a theology that recognizes the inevitability of secular solutions enabled through individual ideas and initiatives.

I will also continue development of characters and antagonistic forces as well as key events ...

What does Reg want? For wife, children, profession, community, ??? Esteem, self-actualization. What would the later actually mean?

What has happened to Reg that caused or accounts for his passion(s) regarding Open Access and the Open Society ... ???

The Opening

- 1.) in total perhaps 5000 words and a dozen pages, but seek initial impact within 1000 words and ideally between 250 and 350 words. In other words make sure the first page is gripping for the reader. This must introduce the main character, the hero, the protagonist for the novel.
- 2.) Reg is already a successful attorney with a practice that focuses almost exclusively on IP and patents.
- 3.) His book explores the ethical limits of patent law. He seeks the advice of the Martha Nussbaum character to reconcile legal and philosophical problems, challenges, dilemmas over the social good vs. the corporate, capitalistic ethos that is raging and rampant and escalating within biology and biochemistry.

- 4.) An important poot element will be the interest of the Nussbaum character on the emotional impact of music and the musical performance of Paula.
- 5.) Maybe the military is interested in IP being processed by the law office of Reg ... could this be escalated by some involvement of some foreign government. Would it be possible for the forieign governmen involved with a graduate student attending RU. The foreign student could be Asian or Indian and that may beg a link with Lucy and an engagement of her father.
- 6.) What pharmaceutical manufacturing is going on in India. What US companies are involved and where in India is this going on?
- 7.) What about Sri Lanka?
- 8.) Pursuing the characterization of Lucy as Indian American—she may have been raised as a Christian but now searches for her true roots in Buddhism, and it may be the relationship with the RU biochemist (Which one? Drax, conflict with Paula) that has stimulated the quest to understand Buddhism.
- 9.) How is meditation in Buddhism and Yoga in Hinduism related?
- 10.) In what way or ways do Hindi and Buddhist scriptures and traditions emphasize the relationahip of an embodied mind in the sense of Varela, Thompson and Rouche?

Opening Gambit

Reg Huttering strode across the quad at Riverbned University his gown draped over his forearm while his hand held the mortarboard. His mission was to deliver the graduation ceremony for just 73 seniors. This group was a sliver compared with over 600 graduates 5ive years ago and 2500 graduates a decade ago. As the new Provost he had agreed to help the university reverse its misfortunes and avoid closue or merger. He was a part of administrative overhead that was unsustainable. The university was paralized trying to understand itself and the chaos caused by its own decline.

His meeting earlier that morning in May with President Colin had not gone well. He learned that factions on the Board of Trustees were being adamant about liquidation of assets and closure during the uupcoming summer months. With new facts at hand Reg had been forced to make several changes in his commencement address. Being a voice of optimism was no longer honest or ethical ... a happy face was no longer possible for Riverbend University.

When he accepted the appointment a Provost nearly two years ago, things he should have known were not revealed. Reg could not find any evidence that the President had been deceptive about the situation then. And, all indicators currently pointed to a honest effort by the President and his close associated to do what was right for Riverbend.

But continuing operation with the admission of a new class of students was no longer an opetion worthy of professional honesty and integrity. What was now an important priority was to enable existing students, all 599 of them, to complete a bachelors degree. This meant retaining faculty and

maintaining the campus building.

The board of trustees was now on the fence regarding future financial support. Their positions were echoed by members of the ligislature, some of whom represented other college and university campuses withing the Minnesota system of higher education. Several of these campuses were growing enrollment and adding programs. One, Minnesota State University, a hundred and fifty miles to the South of Riverbend was a vigorous and nationally recognized inistitution even beyond its athletic teams in football and hockey.

Hockey was one bright spot for Riverbend. Players continued to seek Reiverbend because of Coach Barney Mazuppa, a hall of fame player nearly three decades ago and a leader of proven capacities on and off the rink. Students admired the man beyond his athletic accomplishments. There were not infrequent calls for Mazuppa to be appointed President of the University. Some of these were not entirely faceous, including one member of the Minnesota Senate who was a former player on a Mazuppa team that had seriously challenged other players for a place on the US Olympic team.

No longer in fighting trim, Mazuppa, could assume an image of a curmegeon and rattle on about tyopics far beyond the hockey rink or locker room.

1.) Reg and Riverbed may see a path forward through emullating the recuritment methods of their successful hocky coach. This will involve all of the area HS and CC that will become feeders for students in STEM disciplines. Reg has been working with the coach , members of the music faculty and the chemistry department.

2.) He Reg is particularaly enthusiastic about a summer program for which he had obtained funding against some difficult odds and challenges that opened from residency on tghe part of reviewers and foundation administrators to take a chance on a University in decline. up an opportunity at the Ivy League College to participate in a summer research program along with her college roommate, which whom she maintains frequent correspondence.

7.) Her HS teacher has facilitated connection with Riverbend and the summer research program.

8.) The Marquette MI surgeon lso has a family and his wife sone and daughter are generally contennt with a materialsistc existence, but looking for challenges outside of the UP ... Skiing in particular draws tehm to Colorado, Utah and Montana.

9.) His family finds his angel investing and philanthropy misguided ...

Bakewell Chapter 8.

[Heidegger] uses the word 'poetry' in a broad sense to mean much more than arranging words into verses. He traces it to its Greek root in poiesis — making or crafting — p184.

We help things to emerge into the light by being conscious of them, and we are conscious of them poetically, which means that we pay respectful attention and allow them to show themselves as they are, rather than bending them to our will. .p185.

[Karl Jaspers] wrote, 'Heidegger's mode of thinking, which seems to me to be fundamentally unfree, dictatorial and uncommunicative, would have a very damaging effect on students at the present time.' .p191.

20240714 Bakewell Chapter 7. Freedom was the great subject of Sartre's philosophy, above all — and this is no accident — during the period when France was not free. It is central to almost everything he wrote then: The Flies (the play that was in rehearsal when he met Camus), the Roads of Freedom novels, his many essays and lectures, and above all his masterwork Being and Nothingness, which he developed from his years of note-taking and published in June 1943. .p152.

Sartre argues that freedom terrifies us, yet we cannot escape it, because we are it. .p153.

For Sartre, the in-itself and the for-itself are as opposed as matter and antimatter. Heidegger at least wrote about Dasein as a kind of being, but for Sartre the for-itself is not a being at all. It is a 'nothingness', a vacuum-like hole in the world. .p153.

Freedom does not mean entirely unconstrained movement, and it certainly does not mean acting randomly. We often mistake the very things that enable us to be free — context, meaning, facticity, situation, a general direction in our lives — for things that define us and take away our freedom. It is only with all of these that we can be free in a real sense. .p157.

[Sartre] sought to develop a more Marxist-influenced view of human life as purposeful and social. .p162.

After his first trip, Sartre wrote in Le Figaro of how black 'untouchables' and 'unseeables' haunted the streets, never meeting your gaze; it was as if they saw no one, and you were not supposed to see them either. .p171.

Create a protocol for organizing the writing effort and setting and achieving specific goals for daily, weekly and monthly progress in the direction of a worthwhile ideal or goal.

Recognition of the underlying philosophical foundations for DISCOVERY will prove significant and perhaps valued.

Dialogue will be a huge and decided challenge for quality conveyance for virtually every event in this novel. Dialogue will be a signal of the class of characters with whom Reg and Paula interact and inform their respective world views. This includes but is not limited to university colleagues. For instance the photographer encountered by Paula will represent a (vastly) different worldview.

Totalitarian movements thrived at least paartly because of their fragmentation. This fregmentation in modern lives made people more vulnerable to being swept away by emagogues she coined the phrast banality of evil. The most extreme failures of personal moral awareness.

Three simple ideas — description, phenomenon, intentionality — embedded in phenomenalist and existentialist philosophy … The Epoche' of phenomenology was a central feature of Husserl's philosophy … opens a portal on empiricism by eschewing any ideology … the suffix -ism is precluded from meaning anything worthwhile. The "thing themselves" is intentionally separated from any and all preconceptions of consciousness while intensity focuses the mind on *describing phenomena* … this was exemplified by Jean-Paul Sartre in his principle novels and essays.

Principles

Bakewell identifies principles of existentialism:

Experience—Existentialists concern themselves with individual, concrete, human experience.

Freedom—They consider human existence different from the kind of being other things have. Other entities are what they are, but as a human I am whatever I choose to make of myself. I am free — book

Responsable— ...and therefore I'm responsible for everything I do, a dizzying fact which causes—

Anxious—an anxiety inseparable from human existence itself.

Situational—On the other hand, I am only free within <u>situations</u>, which can include factors in my own biology and psychologyas well as physical, historical and social variables of the world into which I have been thrown.

Passionate—Despite the limitations, I always want more. I am <u>passionately</u> involved in personal projects of all kinds.

Paradoxical—Human existence is thus ambiguous: at once boxed in by borders and yet transcendent and exhilarating.

Phenomenal—An existentialist who is also a <u>phenomenological</u> provides no easy rules for dealing with this condition, but instead concentrates on <u>describing lived</u> experience as it presents itself.

Authentic—By describing experience well, he or she hopes to understand this existence and awaken us to ways of living more <u>authentic</u> lives.

The **Nine Signals** of Existentialism are: Experiential, Freedom, Responsibility, Anxiety, Situational, Passionate, Paradoxical, Phenomenal and Authetic.

It may also be well to add *Perceptual* to the above list as **Maurice Merlau-Ponty** is considered an important bridge between existentialism and phenomenology.

It mmay be of great value to explore how these signals are manifest in the curriculums (curricula) of Community Colleges ... if at all ... what are the antagonistic forces that beset faculty and the administrative meakers and shakers at these colleges as well as the universities of which they are all a product (al products) ...

How does music, painting, sculpture, dance literature (as linguistic expressions) fit into a contemporary curriculum in which the STEM disciplines are now increasingly dominant and domineering?

We are in a near constant battle with our preconceptions. And, to a far too great extent those preconceptions are driven by ideology and its extension, theology. The supernatural ... is always standing in the way of descriptive clarity and (expressive) authenticity. *What we perceive we believe*. [[SOURCE: ??]]

Beliefs are just your perception of reality – Linkedin … Perception is a powerful force that can shape our beliefs and opinions. Step Outline

The routine for development of the Step Outline must slice through a lot of extraneous thoughts and connections to focus on the characters involved in each event and what those characters *will* do. This will demand that each of the characters will have a well-defined goal, aspiration, need, or simple as want. Desire defines the character.

The aspiration for the character *in the event* will depend on interaction with another character. Each of the interacting participants in the event will display characteristics that *must* be defined or pre-ordained. And, it may also be that there is conflict related to a characteristic. For instance, conflict may arise over honesty, stamina or grit, trauma may demand resilience, and so forth and so on ...

How will the story narrative provide insight for the reader and for other characters regarding the mental models and procedural thinking. This may entail some hints or even stipulations as to the vision, team dynamics and orientation (cooperation, compliance, forebearance, ...) as well as recognition of systems at play.

Characterizations

Each participant in an event has a name, gender, height, weight, body-build ... these features or traits follow the character throughout the story ... certain characteristics cannot change, or if they do there must be concomitant explanation that is logical and believable.

Religionj may be a prominent or an irrelevant part of a character. Piety may emerge from any religious stance, although the most beligerent or obnoxious would generally be Christian
